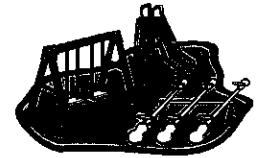


A Privilege to go to Camp

Camp is a Safe Place to be

We are excited to offer fun, safe, and enriching programs for your children. Parents are encouraged to stop by and visit and/ or volunteer during normal hours of operation. Campers not adhering to the safety rules will be asked to leave camp – bullying is unacceptable. Field trips are subject to change without notification due to inclement weather –camper's safety is our number one concern.

Parents can talk to the Staff

Parent concerns, opinions, and suggestions are always welcome. Please feel free to address issues to your camp's Director. Parents who need assistance with issues or have questions about the program can call the Recreation Office at 324-9130.

Campers/Families/Staff Rights and Responsibilities

Children/Staff will be free from mental, verbal, physical/sexual abuse, neglect and exploitation from staff and/or campers. Each person has a right to a safe and healthy environment. Each person has a right to consideration and respect. Each person has a right and responsibility to participate in activities. No hitting, kicking, pushing, pinching, and or shoving will be tolerated. Treat others as you wish to be treated. We believe that rules, expectations, and limits should be applied consistently and explained in a clear and age appropriate manner. Parents have the responsibility to avoid early drop-off, and to be on time for pick-up at the end of each camp day or pay the late fee if not adhered to. Parents have the responsibility to pick up their children without being under the influence of alcohol or drugs. Appropriate camp clothing for the day is a must, warm/cold, rain/shine. Sick children need to be at home. Medications for your child's special needs need to be discussed with the director. P & R not responsible for lost, stolen or broken property (cell phones can stay at home).

Summer Program Policies and Procedures

All participants must have a "Privilege to go to Camp" on file at camp locations. Those wishing for a refund must inquire to the Main Office within the first 3 days of the programs start date. You will receive a household credit or you may request refund by check and will be mailed out within 3 weeks minus a \$10 administration fee. Safety Policies for all programs available for viewing. If class limits are not reached refunds will be given.

Late for camp pick-up

If a child is not picked up by camp close, a late fee will be assessed at \$1 for every minute you are late. (5 minutes late - \$5, 12 minutes late - \$12. This will be billed to the family household account through the office.

Snacks and Drinks for campers to keep the energy level up

We need you to send two snacks and a water bottle with your camper every day. There are designated snack times each day at camp. Providing this for the children allows them to re-energize for the next activities.
