

## SHAWNEE PEAK SNOWSPORTS SCHOOL LIABILITY RELEASE

1. I acknowledge and understand on my own behalf, and if applicable, on behalf of my minor children or wards, that the sports of skiing, snowboarding, skiboarding, snowshoeing and other recreational activities (collectively "SNOWSPORTS") involve risks that may be hazardous to skiers, riders and other participants, including the risk of personal injury, death or property damage. **I AGREE FREELY AND VOLUNTARILY TO ASSUME ALL RISKS**, including the risk of personal injury, death or property damage which may relate in any way to participation in snowsports, including my participation in the Shawnee Peak SnowSports School.

2. In consideration for being allowed to participate in the Shawnee Peak SnowSports School, to the fullest extent allowed by law, I agree on behalf of myself, and my heirs, representatives, and assigns and, if applicable, I agree on behalf of my minor children (under 18 years old) or wards and anyone acting on their behalf including myself, **to RELEASE** Shawnee Peak SnowSports School and Shawnee Peak Holdings LLC, along with their employees, representatives, owners, officers, directors, affiliates, agents, volunteers, insurers, successors and assigns, of and from any and all **responsibility or legal liability** for any injuries, damages, claims, or action in law or equity arising in any way from my participating, and if applicable my minor children's or ward's participation, in the Shawnee Peak SnowSports School.

3. I authorize anyone working at Shawnee Peak to call for medical care and/or transportation to an appropriate clinic or hospital if in the opinion of anyone working at Shawnee Peak medical attention is needed for me or for my minor child or ward. I authorize medical and emergency personnel to administer any medical care deemed necessary in the event that the emergency contact person, parent or guardian identified below cannot be reached by telephone. I agree that upon the calling for such medical care and/or transportation, that Shawnee Peak SnowSports School and Shawnee Peak Holdings, LLC shall have fulfilled its responsibility and shall not have any further responsibility.

4. I further agree to pay all costs associated with such medical care and related transportation and agree to indemnify and hold harmless Shawnee Peak SnowSports School and Shawnee Peak Holdings, LLC along with their employees, representatives, owners, officers, directors, affiliates, agents, successors and assigns from any costs incurred related to such medical care and transportation.

5. I am aware that minor children, while in lessons for snowsports, may ride the chairlift with a ski pro, other children, the general public, or by themselves.

6. (If refusing a helmet) I agree to waive the requirement that all children 12 and under are required to wear a helmet while participating in a SnowSports School Program.

7. I warrant that the participant is in good health and has no physical conditions that would prevent the participant from participating in the Shawnee Peak SnowSports School.

BY SIGNING THIS LIABILITY RELEASE, I ACKNOWLEDGE FOR MYSELF AS AN INDIVIDUAL, OR FOR THE UNDERSIGNED IF A MINOR, AS HIS/HER GUARDIAN THAT I HAVE CAREFULLY READ THIS ENTIRE AGREEMENT, UNDERSTAND IT, AND FREELY AND VOLUNTARILY AGREE TO BE BOUND BY ITS TERMS AND CONDITIONS.
